The Humboldt School Board of Education held a regular/organizational meeting at 5:30pm on Monday, November 15, 2021 at Administration Office Board Room. Roll Call-Satern-Aye, Myott-Aye (by phone), and Mertz-Aye. Newton and Clark were absent. Also present were Administrators, Dr. Paul Numedahl, Ms. Geitzenauer, Mrs. Kester, and Mr. Fedders, Phil Monson from the Humboldt Independent, Tony Beach, Stephanie Hundertmark, Maria Elizondo, Shane Davis, Paul Lauger, Cassie Smith, Emily Lane, Board Secretary, Rhiannon Lange, and Superintendent, Jim Murray.

President Satern called the meeting to order at 5:30pm. Mertz moved, Myott seconded approval of the meeting agenda with addition of Item 5.1, Payment of Bills, Open Enrollment Requests, Resignation, and Personnel Recommendation. Motion carried unanimously.

No one was present to speak during Open Forum.

President Satern presented Champions for Children Award to Tony Beach for his Amazing Creativity within the District/Organizations.

Secretary Lange reviewed the official report from the Humboldt County Auditor and Board of Supervisors for the November 2, 2021 school board election is as follows: For the office of Director District I there were 388 total votes cast with Tate Satern receiving 359 of those votes. For District III, There were 389 total votes cast with Bob Myott receiving 353 of those votes. For District IV, There were 388 total votes cast with Jim Mertz receiving 349 of those votes. For District At Large, There were 386 total votes cast with Shane Davis receiving 349 of those votes.

There were 352 total votes cast with 306 **For** the question and 46 votes **Against** the question.

Mertz, moved, Myott seconded to adjourn the Retiring Board. The meeting adjourned at 5:36pm. Myott left the meeting at 5:37pm.

Davis moved, Mertz seconded to approve the Remaining Agenda. Motion carried unanimously.

Dr. Paul Numedahl, Emily Lane, Paul Lauger and Cassie Smith presented information on Professional Development Visible Learning.

Dr. Paul Numedahl shared High School course enrollment data with the board.

Superintendent Murray reported on the Insurance Committee, District Website Development, Calendar Committee will meet on November 23rd, Staff Shortage-hiring of Special Education Teachers and HS/MS Vocal Music Teacher for second semester, Facilities Planning-getting quotes on construction costs for classroom addition possibilities at Taft and Middle School-December 7th at 5:30pm will be a Special Board Meeting and Student Board Representative will be Maria Elizondo.
